

## Summary


This report will go over the finding of an unmoderated think-aloud protocol testing of the Department of Energy office of Inspector General. Through individual testing, the think-aloud protocol was given to discover what test participants initial feelings and thoughts when browsing the DoE IG home page. The DoE IG home page has a variety of quick links that allows user to snap to their purpose on the website. The testing shows that at initial glance the test participants can discern where to go and the purpose of the website. However, even though test participants can navigate the website easily, all participants gave similar negative feelings when discussing the presentation of the home page. It was commonly noted that the website looked "Cheap, Boring, and Old". This made test participants uninterested in the home page which provided for very mundane think-aloud since participants felt as if there wasn't much to "describe/talk" about. It is our recommendation to maintain the links that are currently on the home page but to revamp the site to allow for a more modern approach to users who are actively on the home page.

### Introduction



The purpose of testing the DoE IG website is to assess how elements are being perceived when accessed by a user. An unmoderated talk-aloud protocol was performed to address a few concerns. The DoE IG website does a great job providing you the links and information to contact representatives when directly entering the page. It allows users to skip navigation and hop straight to their desired location. Although, from the perspective of participants, the visuals, empty space, and lack of color make the website feel baron. While there seems to be little to do on the site in terms of its uses, the simplicity of the website is unattractive. The recommendation for this website would fill in the empty white spaces on the side, allow for a consistent color scheme that flows through the page, and create more attractive personable links for user interaction.

### Methodology




The unmoderated think-aloud protocol will allow users to share their experience while navigating a website in real time. The test participants will navigate the desktop version of the DoE IG website by using prompts created by the facilitator. This testing allows for participants to share user insights that may not be otherwise generated by other evaluations.

We have tested two individuals to answer questions in the think-aloud over the home webpage. Then tested two other individuals to choose from a list of words to describe their initial thoughts on the home webpage.

## Findings

### Home page tour



The unmoderated protocol yielded participants that, during their initial commentary of the page, were able to answer the questions proceeding. The below answers are highlighted in bold.

"Whose site do you think it is?"

#### The us department of energy/ Office of the Inspector General

"What would you do on this site?"

#### **Report Fraud, Waste and Abuse**

"What is the purpose of the site?"

#### To report Fraud, Waste and abuse/ Search for reports and contact the DoE

These questions were answered seamlessly through the obvious initial banner on the front of the page.

The usability of this website isn't the issue in question amongst test participants. However, the design was the most ridiculed and commented the most on.

# Product Reaction Statements



Unequivocally when given a list of words to describe the webpage all test participants answered with the same three words.

#### **Boring, Cheap and Old**

A particular participant went into furthur detail pointing out that the white space on the sides and the different shades of color made it seems as if this was an illagitmet website. Saying "It looks **Fake"** to elaborate his point that the website is very "Government esque" and "underwhelming" to look at.

### Conclusion

The Department of Energey office of Inspector General website was tested in order to expose the outdated web design. Test participants immediately had little positives to say about the design of the web page besidies its simplicity in finding the obivous. Participants choose common words to describe how they felt when using the homepage of the DoE IG. It comes with recommendation that the design of the webpage be brought to a more modern, upbeat aesthetic, that allows users to enjoy the website. By doing this, it allows for a more friendly user experience and breaks down the stereotype that it is another government website.
